We received your letter on April 26, 2004. We will review the information carefully to determine the appropriate action; however, our office will not be able to provide you with any information as to the action taken.

In general, privacy and law enforcement concerns prohibit the Office of Inspector General (OIG) from disclosing information from its system of records to third parties, including the individual who made the original allegation. Often, this is a source of some frustration to those who contact us, but it is unavoidable in light of the Privacy Act (5 U.S.C. §552a) and the regulations promulgated thereunder. Individuals named in allegations received by this office are entitled to the same privacy rights that you or any other citizen might expect from us.
